Memo from Pro-life Leaders to President Trump, Officials of the Trump Administration, Senate Majority Leader John Thune and House Speaker Mike Johnson

We the undersigned leaders of pro-life organizations across America want to express to you our gratitude for the concrete actions that have been taken since the start of the 119th Congress on January 3rd and the start of the Trump Administration on January 20th to advance the protection of the most vulnerable members of the human family, the children in the womb.

These actions have sought to protect children who survive abortions, to protect peaceful pro-life activists who have been unjustly prosecuted, and to protect our taxpayer dollars from funding abortion.
